Routines and behaviours	During the period of home learning, those children who have not attended school may have experienced reduced routines and expectations for their own conduct and behaviour. Compulsory school attendance has not been in place since from March 20th. Lack of routines along with parental and community fear around Covid-19 could potentially impact on the regularity of attendance from Sept 2020. This could be heightened in some schools by the Leicester specific 'lockdown' announced on Monday 29th June (first review date 18th July).
